

The sales and service of alcoholic beverages is regulated by the Washington State Liquor Control Board and as a licensee, Campbell's Resort will not serve minor at any time. All guests will be required to provide proper identification upon request.

Washington State Liquor laws prohibits private liquor from being brought into the same area where Campbell's is providing a liquor beverage service.

No beverage of any kind may be brought into Campbell's meeting/banquet rooms. This policy does not apply to individual suites or hotel rooms.

CASH BAR:

- ◆ 50 person minimum for a private bar.
- ◆ Minimum count will be attendance at bar function. (Should the number be below minimum, a \$25 service charge will be added.)
- ◆ Set fee of \$55 on all satellite cash bars.
- ◆ Bartender's fee: \$75 for the first three hours and \$25 for each additional hour. (3 hour min.) This charge is waived for \$300 in bar sales per 3 hour period.

HOSTED BARS:

- ◆ 50 person minimum for a private bar. (Minimum count will be attendance at bar function. Should the number be below minimum, a \$25 service charge will be added.)
- ◆ Set fee of \$55 on all satellite hosted bars.
- ◆ Bartender's fee: \$75 for the first three hours and \$25 for each additional hour. (3 hour min.) This charge is waived for \$300 in bar sales per 3 hour period.
- ◆ A 20% gratuity will be added to all hosted bar sales.

SPECIAL BARS:

- ◆ Set fee of \$75 on all boat and beach bars per bar.
- ◆ Bartender's fee: \$75 for the first three hours and \$25 for each additional hour. (3 hour min.) This charge is waived for \$300 in bar sales per 3 hour period.

HOSTED BEER AND WINE BAR:

- ◆ \$55 set fee
- ◆ \$30 server fee if less than \$250 in sales.
- ◆ A 20% gratuity will be added to hosted beer/wine.

BARS UNDER THE MIN OF 50 PEOPLE:

FOR SPECIAL REQUESTS:

- ◆ Set fee of \$75 on all host bars under 50 people. A 20% gratuity will be added to all hosted bar sales.
- ◆ Bartender's fee: \$75 for the first three hours and \$25 for each additional hour. (3 hour min.) This charge is waived for \$300 in bar sales per 3 hour period.

COCKTAIL SERVER:

- ◆ \$45 fee per cocktail server for cocktail service. One per 20 people required.

Hospitality Suites

ICE DELIVERY: \$25.00 plus tax (minimum per delivery).

BAR FRUIT TRAY: \$35 plus tax and gratuity.

MINI BAR SET UP: straws, ice, plastic cups and napkins.

\$5.00 per person plus tax. \$50.00 minimum. \$30.00 set up fee.

FULL BAR SET-UP: includes juices, half & half, mixers, bar fruit tray – plus items in Mini Bar set-up.

\$10.00 per person plus tax and gratuity. \$150.00 minimum. \$40.00 set up fee.

GLASS RENTAL: 40¢ per glass rental (wine, beer, highball, champagne), \$3.00 per glass replacement fee.

TABLE RENTAL: 6'x30" or 8'x30": \$45.00 (includes tablecloth and skirting).

NO ALCOHOLIC BEVERAGES ARE ALLOWED TO BE BROUGHT INTO CONVENTION CENTER OR TO ANY LOCATION WITH A CAMPBELL'S BAR.

All set fees and bartender fees are subject to an 8.1% Washington state sales tax.
